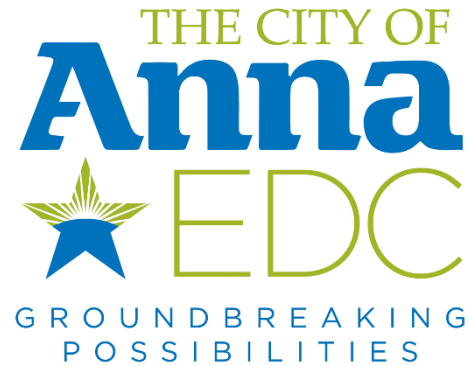




**MEETING AGENDA
